BLMK ICB Guidance on prescribing of drugs excluded from the NHS Payment Scheme (NHSPS) 2023-2025 in Primary Care

The National Tariff Payment System was previously the mechanism for reimbursing hospitals in England for the activity they carry out. This has now been replaced by the **NHS Payment Scheme (NHSPS)** as of 1st April 2023. The NHSPS contains rules for four payment mechanisms that establish the amount payable for provision of NHS-funded secondary healthcare. The NHSPS includes unit and guide prices, calculated using largely the same method as National Tariff prices. The 2023/25 NHSPS has been set for two years (2023/24 and 2024/25).

Within the NHSPS, some high cost drugs and devices are excluded from the calculation of unit prices and national prices (formerly known as PbR excluded drugs). Funding for these items is then either included in a fixed payment or paid for in addition to the price for the related service. Where drugs (as well as services and procedures) are outside of the NHSPS, commissioners and providers decide whether to commission that drug and if so, agree a local price and arrangement for monitoring activity. There is a nationally agreed list of drugs excluded from the NHSPS, but simply because a drug is on that list does not mean it will automatically be funded by commissioners. The commissioning responsibility of these drugs lies with either Integrated Care Boards (ICBs), NHS England (NHSE) or the Cancer Drugs Fund (CDF).

Purpose of the table

In the most part, drugs excluded from the NHS Payment Scheme are specialist drugs provided by hospital Trusts, and therefore primary care prescribers would not be expected to prescribe these. However, there are certain circumstances where it might be appropriate for primary care prescribers to prescribe and the ICB has developed a number of polices for these, usually with associated shared care guidelines. The Medicines Optimisation Team (MOT) has produced a table that lists drugs excluded from the NHSPS and whether these drugs would be expected to be prescribed by primary care prescribers. If a primary care prescriber is currently prescribing one of the drugs listed in the table, they do not necessarily need to stop prescribing as the drug may be included in a shared care arrangement or there may be plans in place to repatriate the drug to NHSE. Information relating to these situations are detailed in the table under 'Additional Notes'. If in any doubt or if clarification is needed, primary care prescribers should contact the MOT (see contact details below). Details regarding prescribing in primary care are outlined as follows:

- 'DO NOT PRESCRIBE' new requests for these drugs and patients currently receiving these drugs (issued in primary care) should be referred to the MOT for advice.
- 'May be prescribed' details for which circumstances and according to which guidelines these drugs can be prescribed are provided in the table.
